The Mayor and Board of Aldermen of the Town of Krotz Springs, State of Louisiana, met in regular session, at the regular meeting place, the town hall, Krotz Springs, Louisiana at 6:30 P.M., January 11, 2022.

The Mayor and Board of Aldermen of the Town of Krotz Springs were duly convened as the governing authority of said town by Mayor Carroll Snyder, who then stated that the Mayor and Board of Aldermen were ready for the transaction of business.

Mayor Snyder reported that Joey Melancon will use Nall Park for is car show on April 23, 2022. Joey will use the park on April 22nd to prepare and April 24th for clean-up. Joey will have security, pick up liter, and the Fire District #1 will use the concession stand. Joey will be required to have a million dollar insurance policy naming the town on the policy. At the next town meeting the Council and Mayor will review a policy for Nall Park and take action on this policy.

On public comment, Nina Snyder reported the fencing around the splash pad is broken and needs to be fixed. Mayor Snyder said to get with Jason Satterly about building a better fence around the splash pad.
