On public comment, Mrs. Juanita Reed reported that Mrs. Joyce Soileau's sewer line was stopped and the maintenance department went two times and could not fix the problem. Mrs. Soileau called a plumber and he fixed the problem which cost her \$150.00 and the plumber said it was on the town side.

On motion of Craig Burghdoff, and duly seconded by Keith Ardoin to amend and adopt a new policy for the rental of Nall Park and Hill Park for non-profit and profit organizations. The motion was carried by unanimous vote.
