The Mayor and Board of Aldermen of the Town of Krotz Springs, State of Louisiana, met in regular session, at the regular meeting place, the town hall, Krotz Springs, Louisiana at 6:30 P.M., March 9, 2022.

The Mayor and Board of Aldermen of the Town of Krotz Springs were duly convened as the governing authority of said town by Mayor Carroll Snyder, who then stated that the Mayor and Board of Aldermen were ready for the transaction of business.

On motion of Keith Ardoin, and duly seconded by Nyssa Godwin to approve the minutes of the regular meeting held on February 8, 2022. The motion was carried by unanimous vote.

On motion of Craig Burghdoff, and duly seconded by Cindy Stelly that all outstanding bills be paid. The motion was carried by unanimous vote.

On motion of Nyssa Godwin, and duly seconded by Craig Burghdoff to adopt a “Resolution Affirming Support for Application for Funding in Connection with Love Louisiana Outdoors Grant”. The motion was carried by unanimous vote.

Mayor Snyder informed Council that the recreation program is accepting applications for Wee Ball and Tee Ball players. We will the number of applicants at the next town meeting.

On public comment, Mrs. Glenda Kelley addressed the Council on the old dump site property, in which she is stating that the property belongs to her. Mayor Snyder said the town will not spend money to prove dump site is ours, that it was up to Mrs. Glenda to hire an attorney to prove the property belongs to her.
