The Mayor and Board of Aldermen of the Town of Krotz Springs, State of Louisiana, met in regular session, at the regular meeting place, the town hall, Krotz Springs, Louisiana at 6:30 P.M., July 12, 2022.

The Mayor and Board of Aldermen of the Town of Krotz Springs were duly convened as the governing authority of said town by Mayor Carroll Snyder, who then stated that the Mayor and Board of Aldermen were ready for the transaction of business.

On motion of Keith Ardoin, and duly seconded by Craig Burghdoff to approve the minutes of the regular meeting held on June 14, 2022. The motion was carried by unanimous vote.

Maintenance Supervisor Nina Snyder said we have two summer workers that are doing great. All is good just cutting a lot of grass.

Mayor Carroll Snyder informed the Council that St. Landry Parish Government gave each municipality \$50,000.00 to spend on operating expenses. Mayor Snyder suggested the town could extend the concrete slab and rood at the back of the Community Center, also extend the front of the pavilion at Nall Park. Bobby St. Romain has submitted a quote of \$18,000.00 for the Community Center.

Louis Polotzola inquired about the clean up of condemned property in town. Mayor Snyder said there is a process and that Mr. Cooney and I rode around town looking at the properties in question. Mr. Cooney will send paperwork on these properties. Mayor Snyder the properties are Latanier Street, Moran Street, and 131 Railroad Avenue.

Mayor Snyder suggested the town should use ARPA Grant for street repairs and a building on Meche property for Second Harvest distribution.
