On public comment Mayor Snyder informed the Council that Mr. Cooney with Building Code is out on vacation but Mr. Cooney will be in town Thursday or Friday to address properties: 131 Railroad Avenue, 457 Bennett Street, 615 Latanier, 111 Railroad Avenue, and 8th Street. Mayor Snyder said Haas the property on 8th Street will be done by the end of the month.

Louis Polotzola had a complaint about the grass on 7th Avenue.

Mayor Snyder said the house on North Levee road, all asbestos has been removed and Haas will soon start tearing it down.
