Mayor Snyder said the November 4, 2020 election will be held at the Community Center.

On other business Mayor Carroll Snyder informed the Council that the prices of water tap and meter needs to increase. The new prices would be \$150.00 for a water tap, meter \$150.00, deposit \$100.00 for water, and \$50.00 connection fee. The pipe cost of 1 and 2 inch would be according to size.
