The generator at the Community Center was struck by lightning and the clerk will check the insurance policy. Nina Snyder requested to put a generator at the water tower for her system incase electricity goes out.

Mayor Carroll Snyder we will put up an enclosure at the library.

On other business Mayor Carroll Snyder informed the Council that the town will celebrate Trick or Treat Saturday, October 31, 2020 from 5:30pm to 7:00pm. Golf carts, side by sides and rangers are allowed and zero tolerance for alcohol.
