The Mayor and Board of Aldermen of the Town of Krotz Springs, State of Louisiana, met in regular session, at the regular meeting place, the town hall, Krotz Springs, Louisiana at 6:30 P.M., June 11, 2025.

There were present: Craig Burghdoff, Larry Martinez, Cindy Stelly, Nyssa Godwin, Keith Ardoin

There were absent: None

The Mayor and Board of Aldermen of the Town of Krotz Springs were duly convened as the governing authority of said town by Mayor Carroll B. Snyder, who then stated that the Mayor and Board of Aldermen were ready for the transaction of business.

On motion of Keith Ardoin and duly seconded by Nyssa Godwin to approve the minutes of the regular meeting held on May 13, 2025. The motion was carried by unanimous vote.

On motion of Craig Burghdoff and duly seconded by Larry Martinez that all outstanding bills be paid. The motion was carried by unanimous vote.

On motion of Nyssa Godwin and duly seconded by Keith Ardoin to approve the Financial Statements and Reconciliation Worksheets. The motion was carried by unanimous vote.

Dana Quebedeaux, CPA, John S. Dowling submitted a schedule of the towns financial. Pages 1 and 2 show the town in its entirety of all funds. The total revenues for the original budget was \$3,190,873, amended budget is \$3,158,795 and the proposed budget is \$3,010,658. The total expenditures of the original budget was \$2,904,312, the amended budget is \$2,849,377 and proposed budget is \$2,902,505. The fund balance/net position was \$8,354,766, amended budget is \$8,309,874 and proposed budget is \$8,418,027. Overall, the town is doing very well.

On motion of Craig Burghdoff and duly seconded by Larry Martinez to approve Special Meeting to Adopt Ordinance No 1 of 2025 and Ordinance No 2 of 2025 on June 25, 2025 at 12:00 P.M. at the Town Hall with a Public Hearing at 11:45 A.M. The motion was carried by unanimous vote.

On motion of Keith Ardoin and duly seconded by Craig Burghdoff to introduce Ordinance No 1 of 2025 "AN ORDINANCE AMENDING THE OPERATING BUDGET FOR THE FISCAL
