Mayor Snyder said he received a call from Vincent Reed concerning the drainage ditch along his property on Todd Avenue. Vincent Reed wants to fill it in with dirt, Mayor Snyder said if he bought the culverts the town will install. Councilman Keith Ardoin said there was a street on that property he suggested that Vyrona Wiltz could research to see if there is a drainage easement.
